## Aerodrome Birrfeld (LSZF): Adjustment of landing charges

### Adjustment of landing charges for PWR-driven ACFT as of March 1, 2024

The board of the Aero-Club Aargau plans in cooperation with the airport management a slight adjustment of the landing charges as of March 1, 2024.

Last time the charges were increased was on July 1, 2018. The inflation, a slight increase in the value-added tax and a more sensible gradation between the different weight, noise and membership classes lead to the following new rates:

The lower internal prices apply when the aircraft is based at Birrfeld (homebase) and the "flying" pilot is an active member of the Aero-Club Aargau. If only one or none of the conditions are met, the rates for external parties apply. The determination of the membership status is stored in the Base Manager and the responsible pilot must log in to the system via his own member or customer login.

This information is also a consultation and is based on the following obligation:

As a licensed airport, the Birrfeld airport is subject to the Ordinance on Airport Charges (SR 748.131.3 - Ordinance of April 25, 2012 on Airport Charges (admin.ch)). Specifically, the procedure described in Articles 39 - 42 of this Ordinance applies to Birrfeld. With regard to noise charges, the relevant provisions are set out in Articles 47 - 49.
