## EAD MIGRATION SWITZERLAND

### EAD Migration Switzerland

#### 1. Introduction

- On 08.03.2013 the Aeronautical Data Base Switzerland (ADBS) operated by skyguide/AIM services has been declared operational as the authoritative aeronautical information source for Switzerland.
- Skyguide has updated their EAD Migration Plan Switzerland to interface the ADBS with the European AIS Database (EAD) for the exchange of the agreed aeronautical information data in line with the former European Convergence and Implementation Plan/ECIP INF01 (*Implement the European Aeronautical Information Services (AIS) Database*).

#### 2. EAD Migration

##### 2.1 EAD Agreement

- Skyguide has signed the EAD Agreement with Eurocontrol as Data Provider.

##### 2.2 Migration Approach

- Skyguide intends to exchange aeronautical information between ADBS and EAD in the AIXM 5.1 format based on a system-to-system exchange. Based on current planning the EAD will not be able to provide AIXM 5.1 exchange capabilities before the end of 2015.
- Skyguide is taking a phased approach for the EAD Data Migration starting with the Static Data (SD). Within the context of the overall SD migration skyguide is starting with the Minimum Static Data as defined in the EAD document "*EAD SERVICE - Minimum Static and Dynamic Data Requirements (Eurocontrol document reference CFMU/EAB/2398 - DOC-EAD-ECN55E-1.0c)*".

##### 2.3 Data Scope

- Skyguide/AIM services will take full responsibility for the Swiss **Minimum Static Data** provided to EAD as from 06.02.2015 becoming effective as from AIRAC date 05.03.2015.
- To keep EAD users continuously updated skyguide/AIM services will publish the data scope for which skyguide takes over the data responsibility.
- The data scope covered by skyguide can be found in the document "*Data Scope Document - Skyguide as Data Provider for EAD*" describing in detail the areas for which skyguide is responsible as Data Provider.
